## IHFA Housing Roundtable Updates Fall 2025

The following is a summary document with updates on IHFA's affordable housing activities across Idaho.

#### Homelessness

#### **Continuum of Care (CoC)**

The U.S. Department of Housing and Urban Development (HUD) tentatively announced awards for the FY2024 CoC competition. Although not yet confirmed, total funding for the Balance of State CoC is expected to be \$5,436,350, which is \$1,385,418 higher than FY23 awards. All CoC renewal grants have a start date of July 1, 2025, and will run until June 30, 2026. The Continuum of Care Program is the largest source of federal grant funding for services and housing for those experiencing homelessness. By statute, CoC Program grants must be awarded through an annual NOFO to which nearly 400 Continuum of Care communities apply for grants for approximately 7,000 homeless services projects.

With the CoC Planning grant funds, the CoC has created a Lived Experience Panel (LEP) and Youth Action Board (YAB). They hope to expand to have at least one LEP and YAB hosting in each Region. Currently, panelists with lived experience of homelessness meet monthly to discuss the strategies, methods, and decisions taking place around the State to help solve homelessness. #### **Emergency Solutions Grant (ESG)**

HUD also awarded ESG funds to Idaho in the amount of \$1,117,066. The ESG grant began on Oct. 1, 2024, and will run until Sept. 30, 2025. The approximate distribution of ESG funding was 41% to Shelter, 31% to Rapid Rehousing, and 20% to homeless prevention projects.

#### Youth Homelessness System Improvement (YHSI) Grant

HUD awarded the HIC \$368,545 through the Youth Homelessness System Improvement (YHSI) grant in June of 2024!

The YHSI grant will support youth facing or at risk of homelessness by building capacity for Youth Action Boards and funding a statewide analysis on youth homelessness and the existing youth homelessness response system. The goal of the study is to gain insight into the socioeconomic and geographic factors contributing to youth homelessness as well as gaps in youth services.

#### The Youth Homelessness Demonstration Program (YHDP) Grant

The HIC was awarded approximately \$3.8 million for the YHDP and Ada County was awarded \$3.2 million. The YHDP is designed to serve youth and young adults experiencing homelessness aged 24 and under. The HIC collaborated with partners across the state on a community planning process. The result of planning is a living document that guides YHDP project work, titled the Coordinated Community Plan (CCP). The local HIC competition is underway for youth-specific projects and closes August 15, 2025. Applicants were required to submit a Notice of Intent to Apply by June 23, 2025. At least 50% of the funding will be allocated to direct housing costs.

#### **Housing Choice Voucher Program**

Idaho Housing and Finance Association (IHFA) receives its funding for the Housing Choice Voucher (HCV) program from the Department of Housing and Urban Development. IHFA is not a federal department or agency. IHFA is a public housing agency (PHA) which is a governmental or public body, created and authorized by state law to develop and operate housing and housing programs for low-income families. IHFA enters into an Annual Contributions Contract (ACC) with HUD to administer the program requirements on behalf of HUD.

IHFA's jurisdiction covers 34 of the 44 counties in Idaho, which are served by IHFA's four (4) branch offices located in Coeur d'Alene, Idaho Falls, Lewiston and Twin Falls). These counties are:


#### **HOME**

IHFA's annual HOME allocation is approximately 5 million. As with last year, IHFA will be utilizing HOME funds for single family downpayment assistance as it evaluates other multifamily loan products with less administrative burden. HOME funds exist to create housing opportunities for households earning less than 80% of Area Median Income. This year, the HOME program and Family Self Sufficiency program are partnering to pilot a downpayment assistance program with rehabilitation. It is hopeful in late 2026, early 2027, HOME funds will be made available to assist income eligible homeowners with rehabilitation loans.

IHFA released its Permanent Supportive Housing RFP on May 15, 2025, and it was due August 15, 2025. \$14 million is being made available of both HOME and HOME ARP funding for the construction of housing. Additional supportive services and capacity building funds are being made available to support non-profits, who are the lead applicant.

"Pass Through" bonds are issued by IHFA to create preferable financing terms and conditions for project owners and borrowers, but which do not offer credit backing by IHFA. Credit risk for these bonds are assumed by bond investors who directly underwrite a project or provide some other credit enhancement.

## **Project Finance Collateral Support Program (CSP)**

Summary Report as of June 30, 2025




The Idaho CSP provides qualified small businesses with additional loan collateral necessary for a Lender to grant the loan. The collateral is in the form of a pledged depository account held by the participating Idaho lending institution, up to a maximum of 20% of the loan amount. 50% percent of approved collateral is funded at loan closing, and if needed, up to 50% percent is funded if a loan loss is incurred. Some of the industries served include retail, restaurants, automotive, transportation, manufacturing, professional services and agriculture.







FGG Brogram Descriptions

Program	Description
FSS	Available to those on an IHFA Housing Choice Voucher who have employment goals.  Counselors assist families in setting individualized goals in areas of employment, education, finances, and service needs. Participants can accrue escrow savings as their earned income grows and the rent portion increases.
Homeless Prevention	Available to individuals living within IHFA's jurisdiction. This funding comes from the Home Partnership Foundation and allows IHFA branch counselors to help with up to \$1,000 towards rent, security deposit, or past due utilities. This is designed to fill the gap and assist individuals without children in the home, but can still help families with children after other resources are exhausted. Individuals can only use this program once every five years. Participants must use the online screening form to check for eligibility.
Housing Counseling	Counselors in the branch offices can help with rental, pre-purchase, and post-purchase housing counseling. This is free to anyone in the community. Some items of conversation are credit, budgeting, applications, homebuyer education, etc.
HOPES	HOPES is a program available only to those individuals who graduate from FSS. This is a down payment assistance program that has two options for financial assistance:  1.3 to 1 match. If an individual is able to save \$3,000, IHFA will triple that and provide \$9,000 towards the purchase of a home. Sponsored by The Home Partnership Foundation.  2. A partnership with the HOME department allowing up to \$200,000 in down payment assistance as a 0% silent second loan. If individual stays in the home for 15 years, 50% of the loan is forgiven. Only due upon sale of the home.
Financial Foundations	A new IHFA program that is available to individuals living at any of The Housing Company properties who do not have a housing choice voucher that offers the FSS program. This program works one-on-one with individuals on their goals in the four corner areas:  1. Income and Education 2. Budgeting and Planning 3. Savings and Emergency Preparedness 4. Debt Management and Credit Financial Incentives: 1. Matching fund: The completion of each goal is tied to \$1,000 with a max earning amount of \$8,000. The first four goals must have one goal in each corner category. Sponsored by The Home Partnership Foundation 2. Home funds: HOME up to \$200,000 in down payment assistance as a 0% silent second loan. If individual stays in the home for 15 years, 50% of the loan is forgiven. Only due upon sale of the home.
Keys to Renting	A renters education program designed to walk a renter through the entire process of renting. A certificate is provided upon completion of the program.

Idaho Housing's branch offices can provide \$1,000\* in assistance once every five years.

# **How Does it Work?**

- Fill out the eligibility screening form.
- The form will tell you if you are tentatively approved or ineligible.
- If tentatively approved, an IHFA housing counselor will reach out to you with next steps.

This is NOT an emergency assistance program.

Funding may take a few weeks to be dispersed.
