NEW ITEMS:

2. Committee Roll Call and Approve Nov Minutes:

- a. Roll Call
- b. Reviewed and approved Nov. 8, 2017 Meeting Minutes: Dena motioned, Donna 2nd. All approve. Meeting minutes approved.

2. Regional PIT Subcommittee Update:

- a. Region 1 (Scott/Donna): Greg has received permission from District Manager for felony probation to have survey takers in lobby. Both Food Banks in Kootenai County are on board. Adrienne has spoken with Gar at 2nd Street. The Recovery Center and Probation will be helping with volunteers. The Presbyterians will allow us to survey during their community meal. Debbie has secured support form LCSC for social work volunteers. Donna will be doing a presentation in Boundary County on Jan 5th. We have received a list of contacts in Shoshone County and Carissa will follow up with that. Three volunteers will be riding buses and Debbie has secured permission to utilize social work students at Lewis and Clark State College.
- b. Region 2 (Steve): Not present.
- c. Region 3 (Amanda): Met yesterday. Presenting to Vets in Treasure Valley. Reaching out to National Guard also. Trying to count veterans. WICAP homeless liaisons reaching out to them individually. Meeting next week to meet with committed members. Sent out food bank letters. Focus on youth homeless, trying to keep contact with them. Flyers handed out to increase awareness. Resource meeting to increase locations for surveying. Volunteers training at the agency's request.
- d. Region 4 (Misty): Not present.
- e. Region 5 (Sarah/Amber): Met several times and have identified site in Franklin county and connection with the tribes. Some in Pocatello and more urban areas. Working with school counselors and homeless liaisons for Youth count. Leslie is taking them surveys and incentives. Amber reached out to ISU for a site there. Volunteers training mid Jan. at the region coalition meeting.
- f. Region 6 (Dena): Have met a couple of times. Many volunteers. Shooting for Jan 11 for training.
- g. Region 7 (Alissa/Howard): ICA was here last week and met with PMWG, working on methodology. Finalizing online tools. Getting paper surveys in case the online doesn't work. Mid Jan for volunteer trainings.

4. PATH Peer Specialists Survey Process:

- a. Peer specialists will administer the PIT Count survey to everyone they talk to during the week of the count. They will need to attend your trainings and get surveys and incentives.

They should be surveying everyone they come into contact with that week during Street Outreach. Employed by Jannus, they work only 19 hrs a week. Every region in the state does Street Outreach or serves At Risk of Homelessness AND has a mental illness to qualify for the PATH program. Regions will work on getting the PATH Peer Specialists together.

The list of PATH Peer Specialists for each Region is attached to the end of this document. IHFA can get the surveys to them but the incentives would be regionally distributed. We can give the list of the trainings for each region to the PATH Peer Specialists.

Need volunteer liability forms signed.

5. Regional Training –Update Training:
