Contact with HC Access Points

- Region 1- Had first meeting Nov 20th. They are set up with the framework of where to go. Next meeting is Dec 20th where they will get solid numbers of volunteers and assign stations. Jan mtg will be vol training. They are working with St Marys, Tribe, library and buses to expand outreach.
- Region 2- PIT planning is part of the regular regional meetings and Steve does individual meetings with agencies and people for more detailed information. Will meet with Lapwai tribe to train volunteers. Planning on meal events in Orofino and Wipea, Grangeville and Moscow. Will go to the Jan mtg of the Human Needs Council and also working with the hospitals – Cottonwood/Nurses for Wellness. The Rock in Lewiston closed last spring but there is a new warming center in Lewiston that may help.
- Region 3- Melanee from AAFV is helping Amanda this year in place of Teresa. They are contacting the agencies and people who helped last year to see if they will help/volunteer this year. Also working on getting some new agencies such as Jesse Tree and the hospital to participate.
- Region 4- No one from SCCAP was on the call but Amy was in Region 4 and had just attended the regional coalition meeting where she presented an overview of the PIT Count and agencies were interested in helping SCCAP. Someone was there from the Twin Falls Police Dept and said they might be able to get officers to do surveys.
- Region 5- In the process of securing locations – about half are done and are working on the rest.
- Region 6- Met last Thursday and are working on the PIT Count as a coalition rather than a separate committee. They are securing sites and getting volunteers lined up. They will be contacting food banks and district nurses for the rural areas.
