House Idaho Collaborative Semi-Annual Membership Meeting

Meeting Minutes Thursday, October 16th, 2025, 9am – 11am MST/8-10am PST

Heidi, the Guiding Idaho Secretary, noted House Idaho Collaborative (HIC) semi-annual meetings foster community and provide members updates on goals and strategies. Check the HIC's website for more information. Attendance can be found in the Appendix.

SECTION A: HIC Vision, Mission, & Purpose - Heidi Sellick-Diaz, HIC Coordinator

Heidi reviewed the HIC's vision, mission, and purpose. The HIC's authority comes from HUD who sets boundaries on what the HIC can do with federal funding, the full membership who make decisions about Board membership and UFA status and the HIC Committees. The Executive Board, which is Guiding Idaho Committee, sets goals and strategies, decides the *Governance Charter*, and makes determinations about the other committees, Regional Coalitions, and the Administrative Agency (IHFA). The other HIC Committees, Housing Idaho, Informing Idaho, and Engaging Idaho, decide on other Governance Documents related to systems and methods. HIC Committees set goals with the six Regional Coalitions and the Administrative Agency.

<u>SECTION B: Homeless or Housing Anecdote - Mandy White, Lived Experience</u> Board Rep.

Mandy highlighted the importance of including individuals with lived experience (LE) in decision-making and shared updates on the Point-in-Time count (PIT), noting a 2% decrease but a need for more shelter options. The LEP felt the PIT Count number was only representative of about 1/3 of the true unsheltered population and gave input about how to collect better counts. Mandy reminded everyone of the importance of donating to homelessness providers during the government shutdown and invited them to attend the LEP.

IHFA publishes a *State of Homelessness in Idaho Report* annually to inform legislators, stakeholders, and the public about the homeless and housing situation. You can find 2024's on IHFA's website here: https://issuu.com/jasonihfa/docs/2024 homelessness report. This year's report will center on people who have become homeless due to financial constraints or job loss. If you have any stories to share, please contact jamies@ihfa.org.

HIC members shared housing successes such as SCCAP enrolling 18 individuals/families in CoC, CATCH housing 5 families in PSH, one of which was homeless five years, Community Action Partnership's SSBF Housing Veterans Program, and the Alder Apartments in Twin Falls filling-up. The HIC then recognized agencies who have hired and incorporated LE well including

CATCH, Advocates Against Family Violence, LC Valley Youth, Aid For Friends, Salvation Army, St Vincent de Paul in N. Idaho, Idaho Falls Rescue Mission, and Sojourner's Alliance.

<u>SECTION C: Resolution 25-10-01: UFA Adoption - Shawn Walters, Collaborative Applicant</u>

Shawn compared UFA and non-UFA status, highlighting increased flexibility and efficiency in grant management and reporting with UFA status. The board approved IHFA's UFA status, which has been in effect since 2019. 30/62 voting members voted via poll. UFA slides can be found on pages 9-13 of the HIC Book. SECTION D: HIC Nominations - Brenna Frantti, Engaging ID Chair

Brenna reviewed the three Board seats opening in April. Patty Wheeler has served 1 term and is resigning as DV Org. Rep. of Guiding Idaho Committee. Erin Anderson has served 1 term and would like to continue as Developer Rep. of Guiding Idaho Committee. Zena Ebed has served ½ a term and would like to continue as HIV/AIDs & FQHC Rep. of Guiding Idaho Committee. Elections take place at April's Semi-Annual Meeting. Submit nominations by February 1st to your Engaging Idaho Committee Representative or email Heidis@IHFA.ORG. Additionally, Rosanna Campbell joined the Board in April as Region 4's representative. Heidi asked for feedback on which voices are still missing from the HIC's board. Responses can be found in the Appendix. Regions 2,4,& 6 are also holding nominations for HIC Committee Representatives and possibly other leadership positions in April.

SECTION E: HIC 2024-2025 Goal Progress - Heidi Sellick-Diaz, HIC Coordinator

The meeting focused on the HIC's progress toward their three goals: Improve Data Quality, Improve Storytelling through Data Analysis, and the 100 PSH Unit Goal. Heidi highlighted improvements in data quality through a HMIS/CMIS user survey, publishing the Community Analysis Dashboard, and publishing Point-in-Time (PIT) Count data, with a C rating (85%) achieved through efforts by the Informing Idaho Committee and HMIS users. Data quality can improve by collecting annual assessments from clients in projects for over a year and by tracking housing move-in dates.

The HIC has added 94 units since 2023, with six units since April's meeting. Heidi emphasized the need for continued advocacy and collaboration. Report any affordable units to your Housing Committee representative.

During the 2025 Legislative session, Housing and Engaging Idaho, along with the LEP and other HIC members shared updates on the housing and homeless impacting bills proposed and organized to prepare testimonies, write letters to senators, and take other advocacy action. IHFA created a separate email address to send out announcements about bills and advocacy

actions: <u>admin@houseidahocollaborative.com</u>. The new HIC website will provide trainings and resources on advocacy for HIC members and better access information on legislation.

SECTION F: HIC Updates - Heidi Sellick-Diaz, HIC Coordinator

Heidi opened a Zoom Whiteboard for members to share their progress, challenges, opportunities, & changes. Highlights included a successful resource and housing events, challenges in finding a new home for Region 3's Access Point and funding, and updates on affordable housing availability around the State, including The Core Property: https://www.thehousingcompany.org/locations/the-core-apartments/. Heidi mentioned the state-wide work between the HIC, Our Path Home, and the Departments of Health and Welfare and Corrections happening on identifying and reducing people cycling through all three systems. SECTION G: CE Report - Erika Switzer, CE Lead

Erika discussed the Coordinated Entry (CE) Annual Report, highlighting progress made and changes to policies over the past year. She presented survey results from clients, mainstream partners, and providers, noting that areas for AP improvement include follow-up processes and clarity of next steps after being assessed. Kody mentioned the low score on "Good (client) Follow-up" may be partially due to clients' inability to be reached. The report will be posted online with the Semi-Annual meeting materials.

SECTION H: HMIS/CMIS Report - John Gibbons, HMIS Lead

John presented the HMIS-CMIS Quarterly Report, showing length of time households have spent on the Coordinated Entry queue, and data on clients served by Victim Service Providers (VSPs) in Emergency Shelters and Rapid Rehousing (RRH). The RRH data included counts of clients housed during the quarter and clients still waiting for housing. See pages 41-43. He introduced the new Community Analysis Dashboard, which provides quarterly updates on various HMIS metrics and outcomes here:

SECTION I: YHDP Update - Anji Armagost, Collaborative Applicant

The HIC received 3.8M for the Youth Homelessness Demonstration Program (YHDP) grant. Three project types were selected by the Youth Action Board with five projects given funding recommendations. These projects were offered funding to start on or after November 1st. You can find more on page 38.

SECTION J: HIC Presentations - Ali Rabe, Mandy White, Charles Hale, & Zeb Moers

Mandy presented on the LETA training by the National Coalition of Homelessness, highlighting its impact on LE and the importance of including individuals with LE in policy discussions. There

were nine Lived Experience Panel (LEP) members enrolled and four graduates. Mandy and Charles praised the course and its segment on the "History of Homelessness."

Ali introduced a new organization, Gem State Housing Alliance (GSHA), which launches next month, and discussed its potential impact on homelessness work across the state. GSHA is a pro-housing advocacy organization in Idaho focused on increasing housing supply and addressing high housing costs. Ali outlined their mission, funding sources, and plans to work with cities on policy changes, provide technical support, and educate the public about the need for more housing. American Enterprise Institute's study claimed a 55k home shortage in Idaho. With policy changes we could create at least 12k more homes each year. Ali and Casey Bolt discussed the need for subsidized and workforce housing, and improved zoning laws. For more information contact info@gemstatehousing.org or ali@gemstatehousing.org. Zeb shared the "Workforce Housing 101" course developed by LEAP, which provides free online training to government officials, developers, and service providers on building workforce housing across Idaho. <u>SECTION L: Announcements & Closing Remarks - Heidi Sellick-Diaz, HIC Coordinator</u>

Heidi emphasized the importance of creating a unified message about homelessness in Idaho for legislators and community leaders, encouraging attendees to share suggestions with their Engaging Idaho representatives. Updates were provided on upcoming events, including housing roundtables, the Point-In-Time count, and the Avenues for Hope fundraiser. Shawn discussed changes to NSPIRE standards and HUD's stance on housing-first initiatives, while Heidi highlighted the need for feedback on these changes. The conversation ended with a reminder of upcoming deadlines and a call for continued dedication to reducing homelessness in Idaho.



That's something that the HIC has not been able to spend much effort on, and so I'm excited to... that we're... we can partner in this way, so thank you.

Mandy White: Heidi, I have one more. I want to say thank you to Charles for stepping up and helping with the lived experience panel. It's been a very super busy year for me, so, he's really been vital in helping us stay on track, so I really appreciate him and all of our regional leaders that put on our lived experience panel. It's... It's amazing.

Charles Hale: Yeah, and I want to, I want to thank Mandy as well, for just being an advocate for her lived experiences family. It's great to have that voice out there. I also want to recognize Heidi, there's times in my day where I think I've spread pretty thin, but I can't even imagine how you do it, but you do it very well, so thank you.

Heidi Sellick: Thank you. I want to thank, Casey Mattoon and Lorenzo, and Dana, some of you know that the HIC is working with Our Path Home, the other COC, and Department of Corrections, and the Department of Health and Welfare on how we can reduce homelessness through reducing recidivism and the cycle that people go through, through hospitals, homelessness, and jail, and so we're really working on getting the data for that. Thank you to BSU, as well, for helping with that, because this is gonna be a huge. I think it'll... it's a really big

effort, and once we have that data and we can kind of start targeting populations and finding ways to reduce that cycle, I'm really excited to see how that will work.

Tami Moore: I want to piggyback on what Charles was saying, about you, Heidi, and just the wonderful leadership that you show, you know, through all of our plannings and meetings and, and... but all of IHFA, and creating this space where we feel safe and we feel, you don't make us feel stupid in our questions. John, Sonali, yourself, I mean, you've always been there, very receptive to the things we request, or ask, or questions that we have, and creating this, like, individual attention, but also creating this, team spirit space, and...Connecting us all together, which has really been, I've seen in the last couple years. it has grown so much, and I really feel that the team that we have here in Idaho, all across the regions, has been tremendously improved because of the work you guys do.

FazzioJ: Hi, I don't know if you can hear me. All right, great. Well, I am actually new here. I'm taking over, Jessica Vasquez was the McKinney-Vento liaison, and it's been a wonderful experience. And then also, just throwing in there, your guys' marketing team, Amara, unsung hero of IHFA, sending out all of these amazing, marketing materials and our access point flyers and cards and stuff, and making changes, and It's fantastic, so thanks.
